Hoben moved and McCleary seconded the motion to approve the renewal of CodeHS curriculum at a cost of \$12,594.00. Motion carried 5-0.

### Approval of Secondary Handbook Changes

McCleary moved and Riggan seconded to approve the secondary handbook changes. Ziegenhorn moved and McCleary seconded to amend the original motion to change under College or Trade School Visits, Apprenticeships & Military Visits from "Seniors are allowed up to two college visits per year with counselor approval" to "Seniors are allowed up to three college visits per year with counselor approval.
